TEAM ACT: Automatic Contribution Transfer (EFT)

Thank you for your inquiry regarding TEAM's Automatic Contribution Transfer (ACT) program. TEAM ACT is a service that authorizes TEAM to deduct contributions automatically from your checking account through electronic funds transfer (EFT). ACT saves time and money by avoiding mail delays and the cost of postage and checks. It also helps TEAM achieve better stewardship of your contribution by reducing processing time and avoiding credit card transaction fees. Are you ready to get started?

Complete and Submit the TEAM ACT Enrollment Form

- ✓ Enter your name and contact information in the spaces provided. If you do not know your Donor ID number, we will complete this field for you.
- ✓ Enter the name of each missionary and/or project that you would like to support.
- ✓ Fill in the amount you would like to contribute monthly to each designation listed.
- ✓ Select the date of your monthly contribution (10th or 25th day of each month).
- ✓ Read the Terms of Agreement, sign and date to acknowledge your acceptance.
- ✓ Return completed form and voided check. Please do not send a deposit slip.

Next Steps

After receiving your completed form, we will pre-authorize your contribution with your bank in order to begin your monthly withdrawals. You will receive an email or letter to confirm your enrollment in this program and notification of your contribution start date. This process normally takes about six weeks. A record of each deduction will appear on your monthly bank statement and you will receive a quarterly receipt from TEAM, as well as an annual statement for your tax receipting purposes. To discontinue or make changes to your contribution, please contact the Donor Relations office at 800-343-3144 or by email at donors@team.org. Requests to increase the amount of your contribution or change bank accounts must be done in writing.
